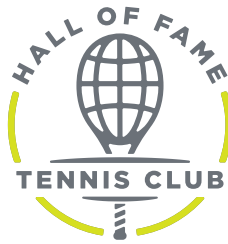

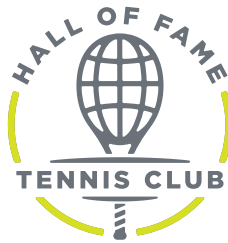

GENERAL WAIVER

All persons who use facilities such as the Hall of Fame Tennis Club at the International Tennis Hall of Fame for the purposes of exercise, athletics, health, and related activities, assume the risk of injury and property damage.

It is expressly understood, therefore, that every person who uses the facilities of the International Tennis Hall of Fame, for and in consideration of being permitted to use and enjoy its facilities, releases, waives claim against and agrees to indemnify and hold harmless the International Tennis Hall of Fame Incorporated (doing business as the International Tennis Hall of Fame, the Hall of Fame Tennis Club), its officers, owners, agents, and employees in connection with all risk and liability for any and all loss or damage on account of injury to the person or property of such person, except injury caused by gross negligence of the International Tennis Hall of Fame or others acting on its behalf, and arising out of the use of its facilities. For the purposes of this waiver, the facilities of the International Tennis Hall of Fame include, but are not limited to indoor and outdoor tennis courts, croquet courts, court tennis courts, social areas, offices, dressing rooms, showers, pro shop areas, grounds, leased facilities, driveway, and parking areas.

The undersigned person expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and extensive as permitted by the laws of the State of Rhode Island, and that if any portion of this agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. Every person who uses the facilities of the International Tennis Hall of Fame acknowledges by such use that he or she has read this Waiver and agrees that it contains the entire understanding between him or her and the International Tennis Hall of Fame, and the Hall of Fame Tennis Club with regard to his or her risks.

FITNESS FACILITY MEMBERSHIP

I hereby authorize the Hall of Fame Tennis Club to automatically charge my credit card for the Fitness Center Membership each month. Pricing is based on my Club Membership package. This entitles myself and those on my membership account (if applicable) to unlimited usage of the fitness center from the activation date. I understand that each month this agreement will automatically renew unless I choose to cancel my Fitness Center Membership, with 30 days notice. At the beginning of each month, my credit card on file will be charged the monthly membership fee associated with my club membership selection. My credit card will be charged on the same date each month. I understand that I will be notified if my credit card fails to authorize payment for any reason, and that a \$10 late fee will apply if I do not provide a valid credit card within 5 calendar days of the rejection date.

MEMBERSHIP REFUND POLICY

Membership fees paid to the Hall of Fame Tennis Club are non-refundable under any circumstance after the first 10 business days of the signed agreement. Written communication of BUYERS RIGHT TO CANCEL within the 10-day grace period can be made by mail or in person to the General Manager of the Hall of Fame Tennis Club and a full refund of membership fees will be provided. Any and all miscellaneous fees incurred during this 10-day period will be subtracted from the refund if necessary.
