SANCTIONED BY THE UNITED STATES TENNIS ASSOCIATION IN 1954. THE FIRST
CLASS WAS INDUCTED INTO THE HALL OF FAME IN 1955. IN 1986, WE ACHIEVED
WORLDWIDE RECOGNITION AS THE SPORT'S OFFICIAL HALL OF FAME BY THE
INTERNATIONAL TENNIS FEDERATION. INDIVIDUALS ARE ELECTED BASED ON THEIR
RECORDS OF COMPETITIVE ACHIEVEMENT, WITH ANCILLARY CONSIDERATION GIVEN
TO SPORTSMANSHIP AND CHARACTER. INDIVIDUALS ARE ELECTED IN ONE OF THREE
CATEGORIES: PLAYER, CONTRIBUTOR, AND WHEELCHAIR. A SERIES OF VOTING
PANELS REPRESENTING THE INTERNATIONAL TENNIS COMMUNITY VOTE TO ELECT
