

General Aviation Charges

Only flights with a maximum number of 15 passengers may be handled via the General Aviation facility. Flights with an exceeding amount of passengers have to be handled via the public terminal. In particular cases, an exceptional permission might be applied for.

Please note:

- In case of baggage, which does not comply with currently valid hand luggage stipulations according to the legal regulations and will, therefore, have to be treated as registered luggage, the General Aviation department has to be contacted in advance. Furthermore, the hand luggage stipulations as to the transport of liquids in hand luggage have to be adhered to.
- In case of surcharges, only the respectively higher surcharge will apply.
- If available, hangar space might be rented on a daily basis upon request.
- Standard opening hours:
Monday – Friday from 6 a.m. till 8:00 p.m.
Saturday, Sunday and on public holidays from 08:30 a.m. till 6 p.m.

Handling beyond those times are possible upon announcement in due time and at surcharges (see „Handling beyond standard opening hours“ in the chapter „Surcharges/other additional services“).

- Taking aircraft into or out of the hangar and refueling is possible from Monday to Sunday from 06:15 am to 09:45 pm.
- Upon request, a specially delegated contact person might be at your service during the standard opening hours as well (VIP handling). The VIP handling can be booked additionally at a surcharge (see „VIP handling“ in the chapter „surcharges / other additional services“).
